


INTRODUCTION

Plan Area

The County of Cypress is a municipal district in southeastern Alberta and surrounds its urban municipality neighbours, the City of Medicine Hat and the Town of Redcliff. The County is over 5,000 square miles or 13,000 km2. Its boundary reaches the Alberta-Saskatchewan border to the east and the Canada- USA border to the south. Cypress County lists eleven hamlets, and each has a variety of indoor and outdoor facilities and parks. The plan area primarily looks within County boundaries and factors in the regional collaboration and facility cost sharing with the City of Medicine Hat to assess recreation opportunities.

Clearwater; Diamond Jubilee; Dunmore; Elkwater; Hilda; Iddesleigh; Irvine; Jenner; Longfellow, Ralston, Schuler, Seven Persons, Suffield, Veinerville, and Walsh.



Purpose of Plan

The purpose of the Cypress County's Recreation Master Plan is to create an attainable mission and clear direction for the sustainable delivery of recreation and parks services for the next fifteen plus years. The mission, goals and strategies serve as a framework for the long-term use and development of facilities and parks, and the implementation of vital recreation programs and services. This comprehensive view of recreation ensures the highest and best use of the County's facilities and programs. The plan is designed to assist decision-makers, key stakeholders, and residents in understanding and identifying the needs and priorities related to recreation and park facilities and programs within the County.









The Recreation Master Plan is guided by the County's Strategic Plan and Municipal District Plan and the Framework for Recreation in Canada: Pathways to Wellbeing. The vision and goals in the Strategic Plan and the objectives in the Municipal District Plan is the foundation for the development of the Recreation Master Plan and the new recreation and parks mission and goals.

Cypress County's Strategic Plan Goals Are:

- Ensure infrastructure is effectively maintained, enhanced and evaluated.
- Provides high quality safe and affordable services and amenities.
- Recognized for its strong partnerships and community engagement.
- Focus on economic growth, sustainablity and diversification.



The Plan helps achieve an enhanced quality of life with a clear strategic direction and achievable goals and strategies to build healthy and connected communities in the County. The Recreation Master Plan provides recommendations for immediate implementation and short, medium, and long-term strategies. These recommendations will help the County maintain and build collaborative relationships and partnerships to develop a sustainable delivery of recreation and park services for the next fifteen plus years.







Planning Process

The Recreation Master planning process creates a new direction for the future. The planning process completes an assessment of the current state of recreation and parks services (programs, facilities, parks),; stakeholder and community consultation to determine current needs and future demands, and provide recommendations for the sustainable delivery of recreation and parks services. The plan also develops an implementation plan with costs estimates for each strategy for the long-term phased approach for facility and program development.



Impact Of Covid -19 Pandemic On RMP Process

As we are all aware, this year, we are confronted with an unprecedented crisis and something the world has never experienced before. Each of us is working from home, practicing social distancing, and finding new routines to keep ourselves safe. During the first week of the shutdown, Quantum Recreation executed the second stage of community engagement, including train the trainer session to host an open house, and seniors and youth surveys. The closure created new challenges for our team and the engagement process. We rewrote the engagement plan, pivoted our process to facilitate a focus group with community leaders, and sent out a user group survey. The feedback received provided essential information to develop a draft recreation plan.








VALUE OF RECREATION

Cypress County is making the following commitments to develop recreation and parks and is stated in its Municipal Development Plan:

- To promote the development of the recreation potential of the municipality.
- To conserve the natural environment of the municipality, especially the river valleys and coulee areas, & existing wetlands and riparian areas.
- To preserve and protect identified historical resources within the municipality.

Recreation is the experience that results from freely chosen participation in physical, social, intellectual, creative, and spiritual pursuits that enhance individual and community well-being.

The fundamental purpose of recreation and parks is to have everyone engaged in meaningful, accessible recreation experiences that foster individual well-being, community well-being, and well-being of the natural and built environment.





And both are used as a foundation to create a new direction for the County's Recreation and Parks service. The new path will identify concrete ways to develop a collaborative approach and build partnerships to expand recreation, sport, and cultural programs and enhance recreation and park facilities. The Master Recreation Plan is a road map that delivers a variety of recreational and outdoor experiences for all to enjoy. It boosts the physical and mental well-being of residents, builds healthy families and communities, and connects people with nature.




COMMUNITY PROFILE

County Demographics and Population Growth

The plan aims to encourage sustainable growth and expansion of recreation, sport, and outdoor recreation over the next fifteen plus years. According to the 2016 Cypress County, Municipal District Stats Canada Census, the population of Cypress County is 7,662 people who occupy over 2,683 residences. The County's population is growing at a rate of 1.14% per year.

















Changing demographics influence recreation preferences. According to the 2017 Alberta Survey, walking is popular among all age groups. Residents living in the County have an average age of 37 years, with the largest segment of the population aged of 45-64 (2,420). Older age groups tend to favour less strenuous activities, while younger people choose more active pursuits. Baby boomers are expected to be more active as seniors but drive demand for less demanding recreation endeavors.

The County's demographics and population growth can guide how the County develops future recreation and park services. The County is growing, however not quickly, which provides an opportunity to plan for the growth. Also, the changing demographics may influence the recreation preferences of residents and requires offering a diverse range of recreation and park services to meet the new demands, whether for youth, women, seniors, or various ethnic groups.

Planning Context

The various National, Provincial, Regional, and Municipal documents present important policy direction and context for planning the County's recreation and park services. The summary of the documents provides the regulations and planning requirements and their impact on the development of recreation facilities, park spaces, or natural areas.

Recreation Trends and Analysis

As our population changes, so do our expectations of recreation and park activities or experiences. Planning today for the needs of tomorrow is a challenging exercise. Cypress County is a unique community. Decisions made today understand and consider the broader trends occurring in the recreation and parks sector to meet the needs of the County for tomorrow. Below highlights the trends in parks, recreation, sport, lifestyle, leisure, and facilities.



Key Trends in the Parks System

- People want to live near parks and open spaces as they are associated with a higher quality of life.
- Parks are increasingly viewed as an opportunity for non-programmed recreation and cultural activities and are built for all ages to use.
- There is an increased demand for gathering spaces such as public picnic areas or outdoor barbeques, particularly in communities with diverse ethnic populations.
- A resident living in Alberta continue to express concern for environmental issues. The increased awareness of environmental protection has made the integration of environmental features in active parks more popular. Also, there is a growing demand for education and public awareness programs focusing on environmental and park-specific issues including stewardship.







Key Trends in the Parks System

- Recreation infrastructure across Canada is ageing, and facilities' overall lifecycle is ending at a faster pace than it is being replaced. If the current reinvestment levels are maintained, there will be a decline in the overall condition of recreation facilities in the coming years.
- The emphasis for the design and build of recreation and parks facilities today is requiring inclusion and access for all members of the population. Our public facilities need to ensure there are no physical barriers that prevent participation to any members of our population.
- There has been progress by governmental bodies across the country to provide gender-neutral washrooms that are equally inviting for all people, regardless of their gender identification. People are to feel welcome and able to enjoy facilities without fear of discrimination.
- Nousing a range of facilities under one roof creates a natural gathering space for the community that can function as a neighborhood hub. Operating recreation facilities as hubs, rather than solely as sports centres, helps with social cohesion and well-being for the community.
- Plexible and adaptable spaces are being created to fit a variety of uses and demands, and more specifically meeting the need for unstructured activities.
- Novements toward sustainable design and ethical sourcing of materials are increasing and include recreation and parks facilities and services. New facilities are being manufactured to meet environmental standards such as LEED (Leadership in Energy and Environmental Design), while older facilities are being retrofitted to introduce energy-efficient systems. Facilities that can attain net-zero carbon emissions, for example, are often showcased as best practice and leaders in facility design.

Key Lifestyle Trends

- There is increasing momentum in the wellness movement. Lifestyle and recreation are becoming the bottom line for livable communities across the country.
- People are becoming more active but not often enough for optimal health. Recreation professionals are partnering with health care professionals to improve physical, mental and spiritual health through physical activity. This collaborative approach is to tackle the high levels of physical inactivity and obesity observed across the country, largely due to a lack of time and participation in sedentary forms of leisure (i.e. watching television, online activities, etc.).
- To facilitate healthy lifestyles, all levels of government are examining ways to increase physical activity and participation levels through the introduction of programs, funding and other initiatives.

General Trends in the Leisure System

- lncome can be a significant barrier to participation in leisure pursuits. Municipalities need to consider the cost of activities or an individual's ability to afford recreation or sport activities, including entry and equipment.
- Demand for unorganized and drop-in activities is on the rise, and this shift is impacting organized and structured programs. Organized programs are considered inflexible for people with limited free time.
- Municipalities are often entering partnerships with community, non-profit, and private-sector organizations to maximize efficiencies associated with capital and operational costs, so long as the municipality and the community benefit.
- Nolunteerism is declining across the country; therefore, supporting local volunteers is critical to ensuring that these dedicated individuals continue to participate in civic life, and new volunteers are recruited.







Key Trends in Sports & Recreation

- Adults and older adults are embracing the "active living" or "wellness" philosophy, and municipalities are shifting their programming to respond to these new demands.
- Trails (both natural and paved) continue to be one of the most used "facilities" in a community. Trails encourage the popular forms of leisure and active transportation activities, including walking for leisure, cycling, and inline skating.
- There is a decline in children and youth participation in most organized sports. However, soccer continues to be a popular sport and casual activities that fit their schedule.
- Sport and nature-based tourism is a growing market including a focus on family recreation "destination" facilities, as well as passive outdoor sports or activities such as hiking, bird watching, marine and waterfront activities.













SERVICE DELIVERY OF RECREATION AND PARKS TODAY

Recreation Facility Ownership Models

Cypress County has a variety of recreation facilities and includes recreation, sport, community halls, schools, libraries, museums, fitness centres, bowling alleys, parks, playgrounds, and outdoor facilities. There are different forms of ownership models for each of the facilities. The facility is:

- Owned and operated by the County, i.e., Centennial Park in Schuler.
- Owned by the County and operated by Non- Profit Organizations, i.e., Community Association in Clearwater, Dunmore, Hilda, Iddesleigh, Irvine, Jenner, Longfellow, Schuler, Seven Persons, Suffield, Veinerville, and Walsh and Irvine Recreation Centre.
- Owned and operated by a Private Business, i.e., Riding Centres.
- Owned and operated Federal government (CFB Suffield), i.e.Ralston Recreation Centre
- → Joint Use Agreements to use the facility, i.e., the school division.









There is a strong community spirit in the County. It is demonstrated by the extraordinary volunteer commitment from community associations, non-profit organizations, and volunteers. Volunteers are an incredible asset to each community. They facilitate or coordinate recreation and sport opportunities for their children, youth, and families. The commitment from volunteer organizations and support from the County facilitates the development of new recreation programs, the ability to host sporting or cultural events, and the ongoing maintenance of community facilities.

There are eleven community associations. Many of the associations have a partnership with the County to maintain the community facilities and parks within each of their hamlets. The County supports the partnership with financial funding and administrative support for community associations or non- profit organizations. The benefit of this collaborative approach is the community buildings are in good condition, sport and recreation programs are offered to children and youth, and the parks and playgrounds are being maintained.

Cypress County Parks and Recreation Service Delivery

A municipality can choose the level of support either staff resources, building infrastructure, or allocate funding to deliver recreation and parks services. The level of support is on a continuum with four levels: Direct Provider, Enabler or Coordinator, Supporter, and Arms Length Provider.



- Direct Provider: The municipality is the direct provider of recreation and park services for the community. The municipality owns and operates facilities; and implements programs and services coordinated by county staff.
- Description of Coordinator: The municipality provides funding for ongoing investment and maintenance of County-owned facilities such as recreation facilities, parks, or community hallsalso, administrative support to coordinate grant programs and communication.
- Supporter: The municipality fosters partnerships with volunteers and community organizations to provide recreation and park services to enable a wide range of experiences and opportunities. The collaborative approach works together to book facilities, cross-promoting recreation, and sport opportunities by all recreation providers in the community (private, non-profit, or municipal).
- Arms Length Provider: Develop secondary plans and incentives to guide developers toward building recreation facilities and green space amenities as part of new growth areas.

The County currently provides recreation and parks services as an Enabler or Coordinator. The County provides funding to organizations through a grant program and the ongoing investment and maintenance of County-owned recreation, sports facilities, and parks. The County also provides administrative support by coordinating grant programs and promoting recreation, sport, or cultural events.








Inventory of Recreation Facilities and Parks

Before beginning to identify a new direction, it is important to understand the current supply of parks and recreation and how well the current system serves the needs of residents. An inventory of recreation, parks, trails, campground, and environmental areas resources in the County.





Recreation Facilities Driveable Service Area

A tool is used to determine priority areas for all recreation, parks, and trails in the County. The tool uses science-based criteria to assess the current capacity for Indoor and Outdoor Recreation Facilities, Parks, and Recreation Programs whether, a private lot, parks playgrounds, trails, outdoor and indoor recreation facilities, walkability buffer (400 m), and driving (38.7 km).





Indoor Recreation Facilities

Cypress County has a variety of recreation indoor recreation facilities throughout the County. The facilities include recreation and sports facilities (curling rink, ice arena, gymnasium, indoor swimming pool), community halls, schools, libraries, observatory, museums, fitness centres, multi-purpose space, and bowling alleys.

The most common operating model is facilities directly owned by the County and operated by Community Associations (i.e., Irvin Sports Complex). The second model facilities are owned and operated by private businesses (i.e., Ridding Centres). Finally, Not for Profit organizations owned and operates community halls (i.e., Community Associations).

Parks

The County currently has a total of 28 parks and includes regional, neighborhood, and greenways. Park facilities include all the amenities and site infrastructure in parks, such as parking areas, recreation infrastructure, and site furniture.

Parks provide residents with the ability to participate in recreational activities, which are both passive and active. Passive recreation may include benches or barbeque pits, and active recreation may include playgrounds or hosting a special event.

Outdoor Facilities

The outdoor facilities are located throughout the County and provide a variety of sport and recreational activities, including two golf courses, one tennis court, four ball diamonds, six soccer fields, four-sport courts, and four outdoor ice rinks. The County directly owns some facilities (i.e., Hilda Ball Diamonds). Other facilities are offered through joint-use arrangements (i.e., Prairie Rose School Division).

Trails

The trail network within Cypress County currently is over 3.2 km and the current focus of pathways within hamlets and urban centers, creating safe pedestrian transportation corridors for residents. The creation of trails will increase due to urban development and the needs of the community.

Environmental Areas

The County has twenty-two Environmental Reserves owned by the County.

Cypress County has environmentally sensitive areas (ESA), which are defined as "areas that have sensitive resources such as large habitat patches, occurrences for species of conservation concern, and rare habitats" (Fiera, 2014). Mapping has been generated by Alberta Environment and Parks, which illustrates the ESA's throughout Alberta. The County needs to be aware of the potential impacts of development and using lands for recreation within environmentally sensitive areas.

Within the County, there has been land that has been designated Environmental Reserve (ER) under the MGA, which is wetlands, streams, or other environmentally sensitive areas. The primary goal of this designation is environmental protection. The provision of some recreation infrastructure, such as trails or interpretive signage, may be appropriate for these areas.

Finally, working with conservation groups such as Ducks Unlimited highlights other environmental areas. The environmental areas can either be a conservation easement or are owned to help protect important watershed areas that help create waterfowl habitat.

Recreation Programming

Recreational programs in the County for residents range from general fitness, educational programs, or highly competitive sports. For the most part, community associations and partners coordinate the delivery of recreation programs, such as hiring instructors to deliver a fitness class. Sports groups also rely heavily on the efforts of many dedicated volunteer organizations and their members to deliver the right quantity, type, and quality of sports programs.





Cemeteries

The County requested an assessment of the current number of cemeteries and the owners, either County, nonprofit organizations, or private citizens, each responsible for the upkeep and maintenance of the cemetery.

The County has a total of 37 cemeteries, which are spread across the 13,173.25 km2. The majority of the cemeteries are located in the middle of the County.

The furthest southern cemetery site is located at the Wild Horse Burial. The furthest northern cemetery site is located at the Wolfer Children.

Cemeteries Roles and Responsibilities

The Cemeteries Act (2000) describes the roles and responsibilities of cemetery owners and operators. The Act provides direction that cemeteries need to ensure there are perpetual care funds to ensure the grounds are maintained. The Act has provisions for requesting that if a cemetery is not being maintained or becomes delinquent, an administrator may be appointed by the minister to continue the care for the cemetery. If the funds are not adequate for the care of the cemetery, funds can be loaned to the appointed administrator.









Policies, Guidelines, and Procedures

The County's current policies support athlete development, coordinate the community grant process, encourage sponsorship, and set park maintenance standards. Many of the foundational recreation policies are not in place, and this may be due to the current focus on funding volunteer organizations to maintain facilities, deliver services, or host events. The development of policies will clarify processes, roles, and responsibilities and improve planning, formalize agreements, and develop reporting procedures.

The following policy areas to consider developing are listed below:

- 01. Facility Allocation. To develop a policy detailing the process to allocate facility space and times equitable. The policy is used to manage situations when demand exceeds supply or how preferred times are assigned.
- 02. Recreation Fees. To develop a user fee policy for programs and facilities. The County may consider developing a consistent approach that maximizes revenues and the use of facilities for all community associations. The development of the policy can also find differential pricing to encourage the use of non-prime time, or non-residential rates.
- 03. Community Grants. The County has the policy to provide annual recreation funding for communities responsible for recreation facilities. An improvement to the current policy would enhance the existing grant program and formalize reporting processes. The process includes the responsibilities of the applicant and the requirements for reporting to the County. The annual funding grants would be allocated after receiving a yearly report on facilities, programs and events, and a funding accountability report on the completing a new project or program.
- 04. Playground Development, Standards, and Inspections. To develop a policy and procedures on playground development, safety standards, and inspections. Also, to provide procedures acknowledging the partnership between volunteer organizations and the County on the development and maintenance of parks and playgrounds.
- 05. Public Engagement. Cypress County is making a concerted effort to keep residents informed and providing opportunities for input on important issues in their community. The Rural Municipalities of Alberta, in partnership with AUMA, has developed Public Engagement Guide and companion templates. The guide is used to create a Public Participation Policy.
- 06. Recreation and Parks Service Delivery. Develop policies to adopt an community development approach.
 - Define the County's Service Delivery based on a contiuum including Direct Provider, Coordinator, or Enabler.
 - Develop guidelines to build relationship and partnerships to encourage volunteer organizations to continue and grow their role in delivering recreation and parks services in their communities. The guidelines will clarify roles and responsibilities and administrative procedures.
 - The policy outlines the support the County is able to provide to community leaders and organizations to build community leadership and organizational capacity.







WHAT WE HEARD



The Council, Staff and Residents are very passionate about Cypress County.

The communities within Cypress County are small; however, volunteers host wonderful events that everyone comes and pack the halls.





There is a need to clarify the roles and responsibilities of municipal departments and community associations for facilities and parks.

Council is looking for a sustainable financial model for recreation and parks.





There may be community benefit to encourage or support tourism.

The number one barrier to recreation that was noted by the respondents was unaware of activities. This communication concern was identified in verbatim comments and echoed with the favorite indoor activity in Cypress County was none, and that there was a high percentage of respondents that have never been to the facilities in Cypress.

The satisfaction of facilities in the County was that many people feel that the campgrounds are good, and for outdoor facilities, there needs to be increased to the ball facilities in the County.





The majority of the respondents accepted the vision.

The wants for facilities in the County are: Upgraded Playgrounds, public facilities require garbage cans, more trees in parks and campgrounds, indoor pickleball, multiplex in Dunmore.



Community Facilities are in good condition.

The respondents don't feel there is a need for cemetery plots as the majority of respondents have plots already, and others are not looking for any.

Community Halls are an essential gathering place for County residents, and each community is unique.





New Draft Vision: "Cypress County's recreation and parks are accessible to all and engage the community to inspire healthy lifestyles, community spirit and tourism that is financially sustainable."

The majority of respondents feel that recreation and leisure are important to them and their quality of life and will travel over 51km to participate in it; however only want to increase taxes by the minimal amount for better access.



The respondents feel that the County has several strengths like the accessibility, proximity and maintenance with an emphasis on Elkwater as a specific strength for the County. When looking at needs, the respondents would like to see better maintenance, trails and accessibility.

The physical activities are outdoor-based. However, due to the ability to swim at Elkwater, swimming could be indoor-Medicine Hat or outdoor at Elkwater.







Community Development Model



This approach is volunteer-based and works collaboratively to maximize resources for facility management, implementation of recreation programs and services, and create outdoor recreation and tourism opportunities for residents living in the County.

The goal for the community development approach is to:

- Strengthen and formalize partnerships with organizations.
- Foster regional collaboration.
- Support recreation organizations equitably and transparently.
- Deliver recreation service in a responsive and sustainable way.

The model will build community leadership and organizational capacity to coordinate program or event development, find sustainable funding models, utilize a decision-making matrix, and implement communication strategies.




The diagram illustrates the key elements to implement a community development continium.









Develop Capacity: To provide support to bolster volunteerism and build capacity of volunteers, community organization or user groups. This is implemented through developing resources and tools to support recreation partners, creating volunteer recruitment or training opportunities, and providing either administrative or funding support.

Program and Event Development: To support the development of proposals for new or ongoing programs, event, facilities, or park amenities. Also, provide administrative support or funding for these initiatives.

Funding Models: To find the intial recommendation is to enhance funding with County grant programs for individuals, groups and organizations. The funding proposals support new opportunities, facilities maintenance or lifecycle planning, and program delivery.

Decision-making Matrix: is a tool for systematically analyze and evaluate decisions. It can be used for all recreation opportunities, be tied to grant requests and provides a transparent way to make decisions for future recreation funding. (See Apendix C)

Communication Strategies: Develop a communication strategy to increase knowledge of recreation opportunities happening in the community.







Roles and Responsibilities in Parks and Recreation Operations

Given the diverse nature and shear vastness of Cypress County of operations of Recreation and Parks programs and services. It is unreasonable to believe that a single service approach would be applied to each service area. The chart below clarifies the service delivery roles for the operations of Parks Services in the County. The roles and responsibilities to operate Parks are shared between County Departments (Public Works, Agricultural, and Corporate Services) and Community Groups.

Suffield

01. Open Space located north of Ronald Ave and has a baseball diamond. An improvement for this park is referbishing the exising baseball diamond and backstop.







Funding Recreation

The County should explore and pursue alternative funding sources, such as the private sector, developers, government and association/team sponsorship, naming rights, donations, and contributions to support future recreation and park development, upgrades, and maintenance.



Grants

There are diverse and ever-changing grant programs available for recreation funding.

For Trails: A comprehensive source of information on current grant programs is Alberta Trailnet (http://www.albertatrailnet.com). This site includes programs offered by federal and provincial governments, as well by foundations, trusts and other NGOs.

For Recreation Facilities and Programs: Grants are generally is used to fund recreation infrastructure improvements or new recreation facilities or amenities. There is a variety of Federal, Provincial, and other funding sources to support capital projects. Several small grant programs that fund special events (Canada Day) or new youth programs or provide financial assistance to participate in sport or recreation programs. (See Appendix A)

Donation

There are also opportunities for private initiatives or partnerships with private landowners and residents.

For Trails: Landowners may choose to gift cash, land, or a partial interest in the land through a conservation easement to a qualified Land Trust in return for a federal tax benefit under the Income Tax Act. If the conservation easement or land gifted can be certified as 'ecologically sensitive'; additional tax benefits may accrue through the Federal Ecological Gifts (Eco gifts) Program.

Cash donations can also be accepted by organizations such as The Land Conservancy and used for land acquisition.







For Recreation Facilities and Programs: An organized donation program can help to attract these opportunities. For example, donations can be sought, along with a method to acknowledge their support, e.g., the brochure could list donors and partners, in association with recreation facilities and programs.

Bequests

For Trails, Recreation Facilities and Programs: A charitable bequest is a gift to an agency, charity or NGO made in the donor's will. Bequests can be made in the form of money or land. This option might appeal particularly to individuals without heirs or who wish their land to be used for a specific purpose after their death.

Local Improvement Tax / Special Tax

For Trails and Recreation Facilities: A local improvement tax is imposed on a specific area within a municipality to fund service or enhance a particular area. The improvement benefits that specific area rather than the municipality as a whole. Some examples of local improvements are sidewalks, trails, lane lighting, or paving. Local improvement taxes are applied to land. This means that the owner of the land is responsible for paying the local improvement tax. A local improvement tax is allocated as an annual charge that is set for a specific period.

A special tax occurs applied to services or construction that benefit a defined area within a municipality. The municipality would levy a special tax to fund the project. Some examples of special services or construction are waterworks and sewers, boulevards, pavement, drainage ditches, and recreation services. The property owner is responsible for paying this tax.

Naming Rights/Sponsorship

For Trails, Recreation Facilities and Programs: A source of funding is sponsorship, donations, advertising, or leasing space. It is used to offset the operating costs of recreation facilities, programs, or events. The County does have a policy on Sponsorship and understands the value of hosting provincial, national, and international events. The County can take a lead role and provide administrative support to develop strategies and procedures for community associations to increase revenue through sponsorship, advertising, or leasing of space.

Coordination with Infrastructure Upgrades

For Trails: Major infrastructure improvements such as road construction or upgrades may provide opportunities for trails. These could be trails adjacent to the road, trails with a green boulevard, or trails separated from the road edge but still within the road right-of-way.





























3.3. Synthesis of Meeting Results

3.3.1. Key Learnings

The following are the key learnings and themes that came from the online community survey

1. The majority of respondents feel that recreation and leisure are important to them and their quality of life and will travel over 51km to participate in it; however only want to increase taxes by the minimal amount for better access.







- 2. The respondents feel that the County has several strengths like the accessibility, proximity and maintenance with an emphasis on Elkwater as a specific strength for the County. When looking at needs, the respondents would like to see better maintenance, trails and accessibility.
- 3. The physical activities are outdoor-based. However, due to the ability to swim at Elkwater, swimming could be indoor -Medicine Hat or outdoor at Elkwater.
- 4. The number one barrier to recreation that was noted by the respondents was unaware of activities. This communication concern was identified in verbatim comments and echoed with the favourite indoor activity in Cypress County was none, and that there was a high percentage of respondents that have never been to the facilities in Cypress.
- 5. The satisfaction of facilities in the County was that many people feel that the campgrounds are good, and for outdoor facilities, there needs to be increased to the ball facilities in the County.
- 6. The majority of the respondents accepted the vision.
- 7. The wants for facilities in the County are: Upgraded Playgrounds, public facilities require garbage cans, more trees in parks and campgrounds, indoor pickleball, multiplex in Dunmore, off-road vehicle trails and -NOT SURE IF WE SHOULD LIST THEM
- 8. The respondents don't feel there is a need for cemetery plots as the majority of respondents have plots already, and others are not looking for any.
- 9. The survey respondents mirror the actual population of the County, other than being overrepresented in the population categories of 0-4, 10-14, 5-44 and 65-74. The respondents are long term residents and want to reside in the County for at least five more years.
