BYLAW 2022/13

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN CYPRESS COUNTY FOR THE 2022 TAXATION YEAR.

WHEREAS Cypress County has prepared and adopted detailed estimates of the municipal revenues and expenditures as required; and

WHEREAS the estimated municipal operating expenditures and transfers for Cypress County for the fiscal year 2022 are \$ 55,887,390; and

WHEREAS the estimated municipal revenue and transfers from all sources other than taxation is estimated at \$ 28,894,004; and \$ 27,956,286 is to be raised by general municipal taxation; and

WHEREAS the 2022 Alberta School Foundation Fund requisition is \$ 13,059,072 and the 2021 over levy is \$16,487; and

WHEREAS THE 2022 Cypress View Foundation requisition is \$ 476,419 and the 2021 under levy is \$1,919; and

WHEREAS THE 2022 Designated Industrial Property Tax Requisition is \$215,879 and the 2021 over levy is \$638; and

WHEREAS THE 2022 Grant in Place of Property Tax (GIPOT) pays 50% of the Municipal Tax Rate equalling an estimated reduction of \$ 28,546; and

WHEREAS the total estimated revenue to be raised by taxation is \$41,692,450 apportioned as follows;
